Online applications are invited for preparing a panel / selection of eligible candidates of Guest / Part-Time Teachers in different subjects of University Departments and Constituent Colleges of Patliputra University, Patna. The educational qualification, eligibility criteria, submission process of the application form, application fee and other conditions for engagement of Guest / Part-time Teachers is available at the official web-site of the University: www.ppup.ac.in from 08.04.2022. The last date for submission of the Online Application Form is 20.04.2022 and the last date for submission of the hard copy of the online Printed Application Form with required self attested photo copy of all documents / certificates in the office of the Registrar is 07.05.2022 by 5:00 PM. The printed application must be sent to Registrar Office through Speed/Registered post only. Any kind of delay / even postal delay will not be entertained in any case.

- A. The number of vacant post may be changed at the time of appointment.
 B. The appointment shall be for eleven months or till the regular appointment of the teacher is made whichever is earlier.

2. Essential Qualifications

- I. A master degree with 55% marks or an equivalent grade in a point scale, wherever the grading system is followed, in Concerned / Relevant / Allied subjects. Relaxation of 5% marks for SC/ST/BC-I (Non-creamy layer)/ BC-II (Non-creamy layer) Candidate of the state, while Physically Challenged persons from any part of the country will be given relaxation of 5% marks at Master's Degree. But both benefits shall not be admissible to the same candidate. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their master's Degree prior to 19 September 1991.
- II. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/ SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil. /Ph.D. Degree) Regulations, 2009 or 2016 and their Amendments from time to time as the case may be exempted from NET/SLET/SET:
- Provided that regarding recognition of SLET/SET/ the provisions of UGC Regulation 2018 shall be applicable.
 Provided further that the candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/Regulations of the Institution / Organization awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions subject to the fulfillment of the following conditions:-
- a) The Ph.D. Degree of the candidate has been awarded in a regular mode;
 - b) The Ph.D. thesis has been evaluated by at least two external examiners;
 - c) An open Ph.D. viva voce of the candidate has been conducted;
 - d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in refereed journal (UGC Care/ SCOPUS/ Peer reviewed Journal).
 - e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/ seminars sponsored/ funded/ Supported by the UGC/ICSSR/CSIR or any similar agency.

The Fulfillment of these conditions is to be certified by the registrar or the Dean (**Academic Affairs/Faculty**) of the University Concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (shanghai) or (iv) US News World Ranking.

Educational Qualification for Law

Good academic record as defined by the concerned authority with at least 55% marks or an equivalent grade in a point scale wherever grading system is followed, at the bachelor Degree level in Law from an Indian University, or an equivalent degree from an accredited foreign University. Beside this:- Senior Advocates (designated or non-designated) practicing in District courts and High Courts having at least 15 years of professional experience and intending to offer lectures in centers of Law Institutes are eligible to apply as a part time Lecture/ assistant Professor (Part time)

OR

Has worked as Judicial Magistrate/ Judge for ten years.

OR

Has taught at least ten years at Judicial Academy.

OR

Has completed the Post- graduation in Law as per UGC norms with 55% marks

3. Terms & conditions:

- I. The number of vacancy requirement in different subjects is provisional and subject to variation. The university reserves the right to vary the requirements including reservation requirements as per Bihar state.
- II. Only candidates successful in BET organized by Bihar Government will be exempted from NET for the post of Guest Faculty. The exemption from NET and marks prescribed for SLET/SET will not be awarded to SLET/SET qualified candidates from state other than Bihar.
- III. The current Reservation Policy of the Government of Bihar will strictly be followed category-wise and subject-wise as per the roster prepared by the University Administration. To get the benefit of reservation, claim for it must be made at the appropriate column of the application form otherwise the benefit of reservation will not be granted. The benefit of reservation is permissible only to the residents of Bihar. If a candidate under reservation category qualifies in the general merit list he / she will be appointed under the general category.
- IV. Age, experience and all other prescribed qualifications will be counted as on 07th May, 2022. The minimum age requirement is of 23 years and maximum of 55 years.
- V. All certificates and degree regarding educational qualification must have been issued before the closing date of the filling the Online application, otherwise your candidature will be rejected.
- VI. The conversion of grade points into percentage will be done according to the conversion formula adopted by the concerned university. The proof of conversion of formula of the concerned university must be submitted by the candidate. Both the photo copy of front side and reverse side of the result sheet marking grade points should be submitted.
- VII. The experience of only such candidates will be valid who were appointed or whose service was confirmed by University Selection Committee / College Service Commission/ College Selection Committee and duly signed by Registrar of the concerned university.
- VIII. Degree under Distance Mode/ Open University from institutions recognized by the UGC will be valid. The validity of Distance Education Mode will be subject to the circular of UGC issued time to time.
- IX. The engagement of Guest / Part-Time Teachers in no circumstances be linked to regular appointments and cannot be regularized at any stage.

- X. The honorarium will be consolidated in nature at the rate of Rs. 1500/- per class with a maximum of Rs. 50000/- per months as per Bihar Government Education Department Sankalp No.15/A2 01/2014-925 dated 13.04.2021.
Honorarium shall be disbursed once the grant from state government is available.
- XI. The engagement can be terminated by the competent authority at any time without assigning any reason thereof.
- XII. The selected persons shall not be entitled to any other benefit like Provident Fund, Pension, Gratuity, Medical treatment, Seniority, Promotion etc or any other benefits available to the University teachers appointed on regular basis.
- XIII. The selected Guest faculty shall not be entitled to avail any allowance/ facilities being extended to the regular / permanent faculty members of the University.
- XIV. The candidates should not have been convicted by any court of Law.
- XV. All candidates shall have to come on the specified date which fixed by the university for document verification. Failing which they will not be considered for further process of recruitment.
- XVI. In case any information is given or declared made by the candidates is found to be false or if the candidate has wilfully suppressed any information relevant to this employment, he/she will be liable to be removed from the engagement and proper action can be taken as deemed fit by the university authority.
- XVII. Application incomplete in any aspect will be summarily rejected.
- XVIII. The candidature of the candidate will be affected/ rejected if the originals of all required certificates are not presented for verification at the time of interview, and the decision of the University will be final.
- XIX. The competent University Authority reserves the right of any amendment cancellation and changes to this advertisement as a whole or in part thereto without assigning any reason or giving notes.

4. Application Process:

Eligible candidates are requested to apply online with a fee of Rs. 1000/- only for General candidates, Rs. 750/- only for EBC/ BC-I (Non-creamy layer)/ BC-II (Non-creamy layer) candidates and Rs. 50/- for SC/ST candidates as form processing charges against this advertisement by clicking the web-link provided on the University website www.ppup.ac.in the last date for submission of online Application Form is 20.04.2022.

The candidates are required to take a print out of the finally submitted Online Application along with self-attested copies of all the relevant certificates so as to reach the office of the **Registrar, Patliputra University, Kankarbag, Patna-800020** through Speed/ Registered post only latest by 07.05.2022 till 5:00 P.M.

Candidate must mention Advertisement No and Post Applied for on the top of Envelope.

Candidates are required to attach self addressed envelope (Size 16x10 cm) along with the hard copy of Application form Stamp of Rs. 40/- must be affixed on the envelope.

The candidates are further advised that before finally submitting online the application form they must go through carefully the details of conditions and instructions published with the Advertisement.

5. Selection Process:

The distribution of marks for academic career will be same as provided in the statute approved by the Hon'ble Chancellor communicated vide No. BSU 25/2014 1472/GS (I) dated 10.08.2020.

In the event of total marks obtained from educational qualifications and interview being the same, candidates having higher marks in educational qualification will be placed higher in the final merit list. In the event of candidate having the same educational qualification marks, candidates who are older in age according to the date of birth will

be placed higher in the final merit list and in the event of candidates having the same date of birth, candidates whose name appear alphabetically first in Devanagari Script will be placed higher in the final merit list.

6. Important Instructions:

- I. Applicants are required to browse the website of the University www.ppup.ac.in regularly as all the updates shall be notified online only.
- II. For candidate those who have applied earlier vide Advertisement no G/01/2018 need not apply again, but they may update their credentials online and need not to pay processing fee. Candidates will update their current credentials on the University website using their respective login credentials (Through using Login id /Password)
- III. For candidates who have applied earlier vide Advertisement no G/01/2018 and are not willing to apply on a fresh, they may claim for refund of application fees.
